SUMMARY OF COUNTY DEVELOPMENT STRATEGY

County Development Strategy for the period from 2011-2013 is the fundamental Strategic Document of Koprivnica Križevci County, which defines directions of its development and sets out the basic priorities as guidelines for the prosperity.

In accordance with the Article 14. of the Law on Croatian Regional Development, Official Gazette No. 153/09, the County Development Strategy is prepared for the period 2011-2013 (hereafter referred in a text as a County Development Strategy), which represents a document of the local (regional) governments in specifying the objectives and priorities of development of the local (regional) governments. The basis for drafting County Development Strategy for the period 2011-2013 was certainly the Regional Operational Programme of Koprivnica Križevci County for the period 2006-2013 which was adopted by the County Assembly on its 8th session held on June 14th 2006. County Development Strategy is a document that completely updates previous Regional Operational Programme of Koprivnica Križevci County for period 2006-2013 and was made in accordance with the methodology defined by the Regulations on the mandatory content, drafting methodology and evaluation of County development strategies, Official Gazette No. 53/10.

Preparation of County Development Strategy is based on a partnership approach of all stakeholders involved in County development. At the beginning of document preparation, County Prefect issued a Decision on establishing a Working Group for County Development Strategy preparation which is consisted with heads of County administrative departments and directors of regional institutions, as well as representatives of the Croatian Chamber of Economy - County Chamber Koprivnica and Croatian Chamber of Trades and Crafts – Chamber of Koprivnica Križevci County.

Partnership Council composed from 57 members, representatives of the local and regional (territorial) governments, civil society organizations and private sector has also made its contribution through suggestions, proposals and comments to all stakeholders involved in its development. Holder of responsibility and coordination of entire County Development Strategy preparation and development is PORA Regional Development Agency of Podravina and Prigorje, which is also responsible for implementation and reporting on implementation of this strategic document.

Basic components of County Development Strategy for the period 2011-2013 are:

- basic analysis of County's most important areas County location, demographic indicators, environment, economy, employment and unemployment, civil society, inter-county cooperation, cross-border and international cooperation,
- SWOT analysis,
- County vision, strategic goals, priorities and measures,
- financial framework for implementation,
- communication strategy and
- action plan.

The most extensive part of the document is certainly **Basic Analysis**, which provides an insight into the overall situation in all relevant areas in Koprivnica Križevci County. For each of the areas are identified main problems and challenges, as well as development needs which needs to be implemented in the future.

On the basis of **SWOT analysis** are defined basic objectives and priorities of County Development Strategy, as well as measures which provides the basic framework for the realization of those objectives and priorities. SWOT analysis provides a basic overview of strengths, weaknesses, opportunities and threats for the future period.



IMPLEMENTATION RESULTS OF REGIONAL OPERATIONAL PROGRAMME OF **KOPRIVNICA KRIŽEVCI COUNTY 2006-2013**

- Regional Operational Programme of Koprivnica Križevci County for the period 2006-2013 (hereinafter referred as: ROP) was adopted by the County Assembly of Koprivnica Križevci County on June 14th 2006 and till the adoption of County Development Strategy for period 2011-2013 was represents a fundamental strategic document and development direction of Koprivnica Križevci County.
- ROP includes an integrated hierarchy of strategic objectives, priorities and measures for their achievement for KKC area. As a first strategic document, process of drafting ROP was based on a partnership approach of all stakeholders from in KKC – Working group, Partnership board and all other stakeholders which made a significant contribution to preparation and implementation of this strategic document.
- Holder of ROP drafting was Center for Entrepreneurship of Koprivnica Križevci County which in cooperation with the Institute for International Relations coordinated overall preparation of drafting ROP (work of Working Group, Partnership board) and was also collecting project ideas included in ROP Database of project ideas, for the purpose of including all potential proposals from public and private sector. During the call for expression of interest for application of development projects in ROP Database of project ideas, it was collected in total of 487 project ideas/projects with a total value of 2.693.086.999,00 HRK.
- During the preparation of County Development Strategy for the period 2011-2013, PORA Regional Development agency as a Coordinator of document drafting process made an evaluation of all projects registered in ROP Database of project ideas, with the aim of creating a database on projects realization in past five years, as well as on their current status.
- From the total of 487 collected projects, for 484 was obtained updated information on their status. According to division on strategic objectives, within strategic objective 1 Competitive economy was registered 105 projects. Under strategic objective 2 Development of transport and communal infrastructure was registered most of gathered projects, 173 of them, while under strategic objective 3 Strengthening of human resources and raising social standard was registered total of 121 projects. Under strategic objective 4 Sustainable use of natural and cultural values and environment were registered 84 projects.







• Chart 1. provides an overview of all projects registered in ROP Database of project ideas according to their status in 2011. It is evident that majority of the projects (33%) is in implementation, since from 2006 and their registration in ROP Database of project ideas, 15% of registered projects was realized.




Chart 1. Overview of the projects registered in the database of ROP projects by the status in 2011.

IMPLEMENTATION OF COUNTY DEVELOPMENT STRATEGY

- According to the Law on Regional Development (Official Gazette 153/09) and Regulation on the Register of structural units of local and district (regional) self-governments, agencies and other entities established to promote effective coordination and encouragement of regional development (Official Gazette 53/10), there are defined holders and Regional coordinators for drafting County Development Strategies. At national level, Strategy for Regional Development of Croatia is implemented by Regional Development Agency, while on local (county) level, all activities related to regional development are carried out by the body proposed by the County and registered in above mentioned Register.
- Based on the above mentioned Regulation on the Register of structural units of local and district (regional) self-governments, agencies and other entities established to promote effective coordination and encouragement of regional development (Official Gazette 53/10), Koprivnica Križevci County on May 24th proposed PORA Regional Development Agency of Podravina and Prigorje as a Regional Coordinator on behalf of Koprivnica Križevci County, as an institution responsible for coordination and promotion as well as for activities of encouragement and coordination of regional development in the area of KKC.
- According to mentioned Regulation (Official Gazette 53/10) PORA as a regional coordinator established with objective of effective coordination and encouragement of regional development on the level of district (regional) self-government is in charge for implementation of following tasks:
 - coordination of County Development Strategy;
 - drafting an action plan in implementation of County Development Strategy;
 - monitoring implementation of County Development Strategy;
 - coordination of activities related to central electronic database of development projects;
 - coordination of local self-government units activities, related to regional development;
 - participation in activities related to development of supported areas;
 - participation in work of statistical regions partnership councils;
 - encouragement of joint development projects with other units of local and district (regional) self-government, as well as through inter-regional and cross-border cooperation;
 - participation in preparation of statistical region development projects;
 - cooperation with other regional coordinators for creating and implementing joint projects.





SYSTEM OF MONITORING AND REPORTING

- System of monitoring and reporting on implementation of County Development Strategy is established with primary objective of ensuring its effective and transparent implementation.
- Main objectives of monitoring and reporting are as follows:
 - > effective and transparent implementation of defined activities
 - identification and review of responsibility system
 - identification of implemented activities effectiveness
 - > identification of justification for implementation of defined activities
 - updating existing and defining new requirements in the framework of County Development Strategy.
- Key stakeholders within monitoring and reporting on implementation of County Development Strategy are:
 - Koprivnica Križevci County County Prefect, Working group
 - PORA Regional Development Agency of Podravina and Prigorje

responsible for implementation of activities, coordination, preparation and submission of the report to County Partnership Council

County Partnership Council

responsible for implementation monitoring, providing advisory opinions and recommendations and adoption of the report given to County Partnership Council

COMMUNICATION STRATEGY OF KOPRIVNICA KRIŽEVCI COUNTY **DEVELOPMENT STRATEGY FOR THE PERIOD 2011-2013**

- Overall objective of Communication Strategy within the framework of County Development Strategy is to provide information about County Development Strategy implementation, rising public awareness on Koprivnica Križevci County area about the importance of implementation, as well as about specific results of Strategy implementation.
- Specific objectives of Communication Strategy are:
 - to promote County Development Strategy at all levels as a basic strategic document, starting point of development and basis for implementation of Koprivnica Križevci County projects (to clearly promote objectives and priorities, as well as measures whose financing can be realized within national and EU funds);
 - > to strengthen public awareness about importance of County Development Strategy (emphasizing the importance of partnership approach in document drafting, active role and mutual cooperation of all involved stakeholders and importance of involving a broad spectrum of stakeholders in implementation of Strategy);
 - > to ensure transparency in County Development Strategy implementation (clearly defined carriers, activities and evaluation system);
 - > to establish strong mutual relationships between all involved stakeholders, to ensure continued partnership at all levels and thereby contribute higher quality implementation of the strategic objectives defined in the Strategy;
 - to establish a system for effective evaluation of all activities implemented in the framework of County Development Strategy implementation.
- Communication strategy of County Development Strategy is aimed at all stakeholders involved in implementation of the document. Target groups can be divided into three basic groups:
 - target groups at national level,
 - target groups at regional level,
 - target groups at local level.
- Activities of Communication strategies includes the following:
 - Publication of County Development Strategy in printed form, and publication of the documents in electronic form on a web site of Koprivnica-Krizevci County and PORA Development agency of Podravina and Prigorje,
 - Publication of Invitation for submission the project ideas that can be put in a data base of projects in County Development Strategy,
 - Marketing promotion of activities in the media (electronic, print, on radio and TV stations),
 - Marketing promotion of activities by organizing events (trade fairs, events).
